Adoption Statement for the following Supplementary Planning Documents:

- **Planning brief for Amberley Road Adult Education Centre, Amberley Road, London, W9**
- **Planning brief for Ebury Bridge Adult Education Centre, Sutherland Street, SW1**
- **Planning brief for Moxon Street Car Park, W1**

On 26 February 2009 the City of Westminster adopted the Supplementary Planning Documents (SPDs) listed above. These SPDs have been produced for each of the main sites affected by Westminster Adult Education Service's property strategy (Amberley Road, Ebury Bridge and Moxon Street). They set out the planning considerations relating to the sites potential disposal and redevelopment. The SPDs focus in particular on potential land use issues and consider in detail possible amenity, traffic, environmental, design and conservation impacts of future proposals for each of the sites. These SPDs, together with a copy of this Adoption Statement and the Council's statement summarising the main issues raised in representations concerning the SPDs and setting out how those issues have been addressed in the SPDs, are available for inspection free of charge at the following locations:


