These interests include the name of their employer; the addresses of any land within the borough in which the Member has a beneficial interest or a licence to occupy; interests in companies and securities in which they have substantial interests which operate in the borough; and other financial interests. If the home address is included in the original declaration this has not been reproduced here but is included in the registration form completed by the Member and available for inspection at City Hall.
